In the interest of public service, the Governor of Mizoram is pleased to place the services of **Shri James Miahlung**, Junior Administrative Grade of Mizoram Civil Service currently holding the post of Additional Deputy Commissioner, Lawngtlai District, Mizoram at the disposal of the National Commission for Women for appointment to the post of Deputy Secretary, National Commission for Women, New Delhi on deputation on 'Foreign service terms' basis with the following terms and conditions:

- 1. Monthly contribution of pension and leave salary contribution should be paid by the borrowing authority during the active period of deputation.
- 2. If the borrowing authority wishes to retain him beyond 3yrs., it shall initiate action for extension before six months of the expiry of the period of deputation.
- 3. If a situation arises for premature reversion to the parent cadre/department of the deputationist, his service could be so returned after giving an advance notice of at least 1(one) month to the lending department and the employee concerned.
- 4. Since deputation is for a limited duration of time, unless the Competent Authority approved extension of the period of deputation in writing prior to the date of expiry of deputation, the deputationist shall be deem to be regarded as released to the Cadre Controlling Authority even if there is no formal order for relieving the deputationist from the borrowing authority.
- 5. In the event of an officer overstaying for any reason whatsoever, he is liable to disciplinary action and other adverse service consequences including non-counting of the period of unauthorized overstay for the purpose of pension, deferring of any increment during the period of unauthorized overstay till the date on which the officer re-joins the parent cadre.
