## NOTIFICATION

No.A.12018/34/2020-P&AR(GSW), the 19<sup>th</sup> February, 2021. In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Mizoram Rural Development Department DWCRA (Group 'C' posts) Recruitment Rules 1993 notified in the Mizoram Gazette extraordinary issue number 138 dated 11<sup>th</sup> June, 1993, in so far as they relate to the post of Gram Sevika, except as respect things done or omitted to be done before such supersession, the Governor of Mizoram hereby makes the following rules regulating the method of recruitment to the post of Gram Sevika under Rural Development Department, Government of Mizoram namely :-

- 1.Short title and<br/>commencement.-(1)These rules may be called the Mizoram Rural Development<br/>Department (Group 'C' post) Recruitment Rules, 2021.
  - (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. *Application.* These rules shall apply to the post(s) specified in Column I of the Schedule annexed to these rules.
- 3. *Number of posts, classification and level in the pay matrix or pay scale.-*The number of the said post(s), classification and level in the pay matrix or pay scale attached thereto shall be as specified in Column 2 to 4 of the said Schedule.
- 4. *Method of recruitment, age limit and other matters relating to the said post shall be as specified in Column 5 to 13 of the said Schedule.* 
  - Disqualification.-

- No person –
  (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post;

Provided that the State Government may, if satisfied that such arriage is permissible under the personal law applicable to such rson and to the other party to the marriage and that there are her valid grounds for doing so, exempt any such person from the eration of this rule
ery officials recruited under these Rules shall undergo such ining or pass such Departmental Examination as may be prescribed m time to time.
twithstanding anything contained in these rules, the State Government public interest, shall have the right and power to transfer any icials, so recruited under these Rules to any other post or position ich is equivalent in rank or grade.
here the State Government is of the opinion that it is necessary expedient so to do, it may, by order and for reasons to be recorded writing, through the Department of Personnel & Administrative forms, relax any of the provisions of these rules with respect to y class or category of persons.
thing in these rules shall affect reservations, relaxation of age nit and other concessions required to be provided for the Scheduled stes, the Scheduled Tribes, the Ex-servicemen and other special egories of persons in accordance with the order issued by the overnment of Mizoram from time to time in this regard.
