## **NOTIFICATION**

No.A.12018/46/2013-P&AR(GSW), the 1<sup>st</sup> May, 2014. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules regulating the method of recruitment to the post(s) of Deputy Superintendent of Police (Ministerial Uniformed Cadre) under Home Department, Government of Mizoram, namely:

- Short title and 1. These rules may be called the Mizoram Home (Police) Department (1) commencement -(Group 'A' posts) Recruitment Rules, 2013. They shall come into force from the date of their publication in the (2) Official Gazette. 2. These rules shall apply to the posts specified in column 1 of the Application-Schedule-I annexed to these rules. 3. Number of posts, The number of the said post(s), their classification Pay Band and classification, pay band Grade pay/pay scale attached thereto shall be as specified in columns and grade pay/pay scale -2 to 4 of the said Schedule. 4. Method of The method of recruitment to the said posts, age limit, qualification and recruitment, age other matters relating thereto shall be as specified in columns 5 to 14 of the said Schedule. limit, qualifications, etc-Provided that the upper age limit prescribed for direct recruitment may he relaxed in the case of candidates belonging to the Scheduled Castes/the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or the Government of Mizoram, as the case may be from time to time.
- 5. Disqualification(a) who has entered into or contracted a marriage with a person having a spouse living; or

		(b)	who, having a spouse living, has entered into or contracted a marriage with any other person, shall be eligible for appointment to the said post(s);
