Sir/Madam,

Consequent to this Department's Notification of even No. dated 18th October, 2022, in which, all Group 'A' officers under the Government of Mizoram are required to apply all kinds of leave application online through Leave Application Management System (LAMS) with effect from 20th October, 2022, I am directed to inform you that, at present, only 1895 (One Thousand Eight Hundred Ninety Five) out of more than 4500 (Forty Five Hundred) Group 'A' officers have registered themselves on Leave Application Management System (LAMS). And further, it has also come to the notice of the Government that Group 'A' officers under several Department are processing leave applications, **manually**, which is a breach of the Government's Notification, and this need to be curtailed.

Therefore, I am further directed to reiterate that all kinds of leave applications of Group 'A' officers under the Government of Mizoram are to be processed, only, through Leave Application Management System (LAMS), and it is also kindly requested that all Administrative Heads of Departments and all Heads of Departments/Heads of Offices are to ensure that all Group 'A' officers under their Administration/Offices are registered on LAMS on or before 16th December, 2022, positively.
