NOTIFICATION

In the interest of public service, the Governor of Mizoram is pleased to re-employ Er. Laldela Sailo, Chief Engineer (Rtd), Power & Electricity Deptt as 'Consultant' under Power & Electricity Department with effect from the date of joining for a period upto 31.03.2023.

The terms and conditions of the re-employment shall be as under:

- 1. The renumeration shall be at a fixed rate of Rs 34,000.00 (thirty-four thousand) only per month in the form of a consolidated honorarium and shall be paid by the concerned Department on re-employment.
- 2. Pensionary benefits admissible to the retired officer under the relevant provision of rules shall not be deducted on account of payment of a consolidated honorarium.
- 3. His headquarters will be Aizawl only.
- 4. He shall enjoy the same status of the post immediately held prior to retirement, but should perform any work as may be assigned by the concerned department and will have executive powers only.
- 5. The appointment can be terminated at any time by the Govt. by giving him one month's notice in advance.
