In compliance with Judgment & Order dated 07.02.2023 of the Court of Special Judge Prevention of Corruption Act, Mizoram and in the interest of public service and upon having Review DPC and on the recommendation of the Mizoram Public Service Commission vide No. No.A.32013/6/2022- MPSC dated 5th June, 2023, the Governor of Mizoram is pleased to promote **Pu H. Lianzela**, Selection Grade of MCS to Supertime Grade 'B' of MCS in the Level 13A of Pay Matrix plus all admissible allowances with retrospective effect from **01.03.2020** on *officiating basis* i.e. the date on which his immediate junior, Dr. H. Lalthlangliana was promoted to Supertime Grade 'B' of MCS.

Further, the officiating promotion of Pu H. Lianzela, MCS to Supertime Grade 'B' of MCS shall stand regularized with effect from 23.09.2020 i.e the date on which his immediate junior, Dr. H. Lalthlangliana was regularised to Supertime Grade 'B' of MCS.

He is allowed to draw arrears of pay and allowances during the period of his notional promotion to Supertime Grade 'B' of MCS from 01.03.2020 to 13.06.2023 i.e immediately before the date of his actual promotion to Supertime Grade 'B' of MCS.

The promotion is provisional subject to the outcome of appeal that may be filed against the acquittal of the said officer as per instruction vide Government of India's Office Memorandum F.No. 11012/6/2016.Estt.A-III dated 19.01.2017.

Upon his promotion to Supertime Grade 'B', Pu H. Lianzela shall continue to be posted as **Director, UD&PA Department** in his own grade until further orders.


