### NOTIFICATION

**No. A.12018/33(2)/2019-P&AR(GSW), the 28<sup>th</sup> June, 2023:** In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Mizoram Social Welfare Department (Group 'C' post) Recruitment Rules 1986 notified in the Mizoram Gazette Extraordinary issue number 71 (A) dt. 03.11.1986 and its subsequent amendment issue number 448 dated 30.10.2008, Mizoram Social Welfare Department (Group 'C' posts) Recruitment Rules 1997 notified in the Mizoram Gazette Extraordinary and issue number 145 dt. 28.05.1997 and the Mizoram Social Welfare Department (Group 'C' post) Recruitment Rules 2003 notified in the Mizoram Gazette Extraordinary issue number 54 dated 04.03.2003, except as respects things done or omitted to be done before such supersession, the Governor of Mizoram hereby makes the following rules regulating the method of recruitment to the posts of **Warden, Physical Instructor, Security Officer and Educational Instructor** under Social Welfare & Tribal Affairs Department, Government of Mizoram namely :-

1. Short title and commencement.-
  - (1) These rules may be called the Mizoram Social Welfare & Tribal Affairs Department (Group 'B' posts) Recruitment Rules, 2023.
  - (2) They shall come into force from the date of their publication in the Official Gazette.
2. Application.- These rules shall apply to the posts specified in Column I of the Schedule annexed to these rules.
3. Number of posts, classification and level in Pay Matrix.- The number of the said posts, their classification and the level in Pay Matrix or Pay Scale attached thereto shall be as specified in Columns 2 to 4 of the said Schedule.
4. Method of recruitment, age limit and other qualifications.- The method of recruitment, age limit, qualification and other matters relating to the said posts shall be as specified in Columns 5 to 13 of the said Schedule.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes or the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Mizoram from time to time.

5. Disqualification.- No person –
- (a) Who has entered into or contracted a marriage with a person having a spouse living; or
  - (b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post (s);

Provided that the State Government may, if satisfied that such a marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other valid grounds for doing so, exempt any such person from the operation of this rule

6. Training and Departmental Examination.- Every officials recruited under these rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.
7. Power to transfer.- Notwithstanding anything contained in these rules, the State Government, in public interest, shall have the right and power to transfer any officials so recruited under these rules to any other post or position which is not lower in rank or grade.
8. Power to relax.- Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing, in consultation with the Mizoram Public Service Commission through the Department of Personnel & Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons.
9. Saving.- Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Ex-Servicemen and other special categories of persons in accordance with the order issued by the Government of Mizoram from time to time in this regard.
