ORDER

Whereas, the meeting of the **Council of Ministers on 13th of December, 2023** has resolved that all concerned Departments shall take immediate action for the effective implementation of the **Mizoram Right to Public Services Act, 2015** which came into effect from the 1st day of December, 2015 to provide legal framework for citizens to receive specified public services within a speculated time-frame, and to address grievances related to service delivery;

And Whereas, the list of 141 (one hundred forty one) Public Services under the Departments of FCS&CA, Rural Development, Taxation, Transport, PHED, Social Welfare, Finance Department, Commerce & Industries, LR&S, Mizoram Pollution Control Board, LESDE, Excise & Narcotics, UD&PA, H&FW, Fire & Emergency Service, Eco & Statistics, Deputy Commissioners' Offices, Home Deptt., Accounts and Treasuries and Tourism have been notified under the said Act;

Now, therefore, to ensure efficient fulfillment of the above-mentioned decision of the Council of Ministers, all the **implementing Departments** are hereby informed-

- To appoint in their respective Department a Nodal Officer not below the rank of Under Secretary in the Secretariat, and not below the rank of the Deputy Director at the Directorate, and to submit the report thereof with details of the Name, Designation, Official Address, Phone No/Mobile (Whatsapp) No. & email address, on or before 9th of January, 2024, to the Nodal Officer, DP&AR(GGC).
- 2. On receipt of the list of the Nodal Officers, Capacity building/sensitization of the Nodal Officers and Appellate Authorities, **identification of new services**, as well as efforts for **generation of awareness among the public** regarding the Mizoram Right to Public Services Act, 2015 shall be taken up, and proactive role is expected from all the implementing Departments, so that the goals of accountable, responsive, and transparent governance, in short, Good Governance is achieved.

3. That it is pertinent, to ensure efficient disposal of service-delivery related matters, that **functional online systems** should be in place wherever it is lacking, to receive applications from the citizens and for correspondence between the Department and the applicants concerned relating to the services notified under the MRTPS Act, 2015.

A Consulation Meeting on the issues mentioned under paras 2 and 3 above will be convened soon after receipts of the report mentioned under Para 1.
