Sir/Madam,

In continuation of this Department Notification of even No dated 18.10.2022, I am directed to state that all Group 'A' Officers under the Government of Mizoram are required to apply all kinds of leave applications through Leave Application Management System (LAMS) with effect from 20th October, 2022, and a subsequent letter was also issued vide this Department's letter of even No dated 02.12.2022; urging the concerned officers to register themselves on the Portal and to refrain from applying leave manually. It has come to the notice of the Government that out of more than 5000 Group 'A' Officers, only 3687 (Three Thousand Six Hundred Eighty-Seven) Group 'A' Officers have registered themselves on the Leave Application Management System (LAMS) and the number of unregistered Officers is still more than a thousand even after the Implementation of the LAMS for nearly 2 (two) years.

Therefore, it is reiterated that all kinds of leave applications of Group 'A' Officers under the Government of Mizoram are to be processed, only, through the Leave Application Management System (LAMS), only, and that All Heads of Administrative Departments and Heads of Department/ Heads of Offices are requested to expedite the registration and ensure that all Group 'A' Officers under their Administration are registered on the Leave Application Management System (LAMS) latest by 29st February, 2024.
