Subject: Reservation for Ex-Servicemen for re-employment in civil posts under the Government of Mizoram.

Attention is invited to this Department's Notification No. A-12027/1/2016-P&AR(GSW) dt. 10.10.2019 "the Mizoram Ex-Servicemen (Re-employment in Civil Posts) Rules, 2019, published in the official Gazette Issue No. 660 Dt 15.10.2019 wherein it was prescribed that "Five per cent of the vacancies in each of the categories of Group 'B' (Non-Gazetted), Group 'C' and Group 'D' posts falling within the direct recruitment quota in any year shall be reserved for being filled by ex-servicemen". The said rules may be downloaded from the DP&AR website under OM/Notification \rightarrow Ex-Servicemen.

- 2. While instructions regarding adherence to these rules have been issued previously, it is deemed necessary to reiterate their importance. As such, all administrative departments and department heads under the Government of Mizoram must strictly adhere to these rules in their entirety. The number of posts available under the Mizoram Government may be comparatively smaller than those in the Central Government, potentially limiting the immediate utilization of the ex-servicemen quota; however, it is kindly requested that the concerned administrative departments meticulously review the aforementioned regulations and clearly indicate whether there are potential reserved posts for ex-servicemen when initiating proposals for filling posts by direct recruitment.
- 3. In order to ensure widespread awareness, all administrative departments are requested to disseminate this information comprehensively throughout their subordinate and attached offices.
