### NOTIFICATION

**No.A.12018/49/2023-P&AR(GSW), the 27<sup>th</sup> June, 2024:** In exercise of the powers conferred by the proviso to article 309 of the Constitution, the Governor of Mizoram in consultation with the Mizoram Public Service Commission and the Hon'ble Gauhati High Court, hereby makes the following rules to amend the Mizoram District Court Service Rules, 2018 (hereinafter referred to as the principal rules) which was notified under this Government's Notification No. A. 12018/77/2013-P&AR (GSW) dated 01.10.2018 and published in the Mizoram Gazette Vol. XLVII, Extraordinary issue No. 593 dated 03.10.2018 as follows namely :-

- Short title and commencement.-
  - (1) These rules may be called the Mizoram District Court Service (Amendment) Rules, 2024.
  - (2) They shall come into force from the date of their publication in the Official Gazette.
- Amendment of the Schedule.- In the principal rules, in the Schedule A, against category of posts (cadres) relating to the post of District Court Service, the following entries shall be substituted namely:-
