In compliance with Judgement & Order dt.07.06.2024 passed by the Hon'ble Gauhati High Court, Aizawl Bench and upon having Review DPC and on the recommendation of the Mizoram Public Service Commission vide letter No.6/A/2010-MPSC dt.10.09.2024 and in the interest of public service, the Governor of Mizoram is pleased to grant proforma promotion to **Er. Lalsangliana Chhakchhuak**, Selection Grade of MES (Civil) to Supertime Grade 'B' of MES(Civil) under Public Works Department in the Level 13A of the Pay Matrix plus all admissible allowance with retrospective effect from **01.10.2023**, the date on which his immediate junior Er. H. Zoramliana was promoted to Supertime Grade 'B' of MES(Civil), PWD.

Furthermore, as the officer was fully acquitted in SR(PCA) No.09/2015 and Sentence Order dated 15.05.2023 has been set aside, he is allowed to draw arrears of pay and allowance during the period of his notional promotion from Selection Grade of MES to Supertime Grade 'B' of MES(Civil) from 01.10.2023 to 22.09.2024 i.e. immediately the date before of his actual proforma promotion.

Upon his proforma promotion to Supertime Grade 'B' of MES(Civil), Er. Lalsangliana Chhakchhuak shall continue his deputation as Chief Executive Officer, Mizoram Road Fund Board Secretariat under Public Works Department in his own grade until further orders.

The promotion is provisional subject to the outcome of appeal that may be filed against the acquittal of the said officer as per instruction vide Government of India's Office Memorandum F.No.11012/6/2016-Est.A-III dated 19.01.2017.
