Public Notice on draft syllabus for the Mizoram Civil Services (Combined Competitive Examination) Rules, 2025

The Government has been contemplating the discontinuation of the optional subject/paper in the draft Mizoram Civil Services (Combined Competitive Examination) (Amendment) Rules, 2025, for a considerable period. Accordingly, it is proposed to revise the syllabus of General Studies Papers I-IV, enhancing the total marks for each paper from the existing 100 to 150. Further, topics of specific relevance to the state are proposed to be incorporated into the existing syllabus.

GENERAL STUDIES - I

(Indian Heritage and Culture, History and Geography of the World and Society)

UNIT I

- 1. Indian culture will cover the salient aspects of Art Forms, Literature and Architecture from ancient to modern times.
- 2. Mizo history, heritage, culture, and eminent freedom fighters of Mizo Chief against the Britishers.
- 3. Architecture, their significance and maintainability, museum, archive and archaeology of Mizoram.

UNIT II

- 1. Modern Indian history from about the middle of the eighteenth century until the present significant events, personalities, issues

UNIT III

- 2. Role of women and women's organization, population and associated issues, poverty and developmental issues, urbanization, their problems and their remedies.
- 3. Effects of globalization on Indian society, the impact of social media on Indian society, migration on Indian society.
- 4. Social empowerment, communalism, regionalism & secularism.
- 5. Rural, Urban and Tribal issues in Mizoram: social structure, festivals, fairs, music, folk dances, literature and languages/dialects, social customs.

UNIT IV

- 2. Distribution of key natural resources across the world (including South Asia and the Indian sub continent); factors responsible for the location of primary, secondary, and tertiary sector industries in various parts of the world (including India)
- 3. Important Geophysical phenomena such as earthquakes, Tsunami, Volcanic activity, cyclone etc., geographical features and their location changes in critical geographical features (including water bodies and ice caps) and in flora and fauna and the effects of such changes.

UNIT I

- 1. Indian Economy and issues relating to planning, mobilization of resources, growth, development and employment, Economic Development in Mizoram and Sustainable Development and its goals.
- 2. Inclusive growth and issues arising from it.
- 3. Government Budgeting, Analysis of Central and State Budget (Latest ones), Gender Budgeting, Zero Based budgeting and Outcome budget, Centre-State Financial relations, Indian Fiscal federalism, Finance Commission, NITI Ayog, Fiscal Policy, Monetary policy, Reserve Bank of India, Banking system in India, Role of Public Sector Banks, Regional Rural Banks, Private Sector Banks, National flagship schemes/programmes of financial inclusion, Insurance and pensions, Public Financial Management System.
- 4. Major crops cropping patterns in various parts of the country, different types of irrigation and irrigation systems, storage, transport and marketing of agricultural produce and issues and related constraints; e-technology in the aid of farmers, climate-resilient agriculture, organic farming, and



- water conservation techniques, role of biotechnology and genetic engineering in enhancing agricultural productivity, National Programmes for increasing and development of Agriculture.

- 3. Awareness in the fields of IT, Space, Computers, robotics, nano technology, bio technology and issues relating to intellectual property rights, ethical implications of AI, gene editing, and other emerging technologies.
- 4. Statistical analysis, graphs and diagrams. This part will test the candidate's ability to draw conclusions from information presented in statistical, graphical or diagrammatical form and to interpret them.

UNIT III

- 2. Disaster and disaster management, including Mizoram.
- 3. Climate Change, Impacts of climate change on India, Mitigation and adaptation strategies, International climate agreements and India's commitments.

GENERAL STUDIES - IV (Ethics, Integrity, and Aptitude)

This paper will include questions to test the candidates' attitude and approach to issues relating to integrity, probity in public life and his problem solving approach to various issues and conflicts faced by him in dealing with society. Questions may utilise the case study approach to determine these aspects. The following broad areas will be covered.

UNIT I

1. Ethics and Human Interface: Essence, determinants and consequences of Ethics in human actions; dimensions of ethics; ethics in private and public relationships, Environmental Ethics, Digital Ethics, Bioethics, Human Values – lessons from the lives and teachings of great leaders, reformers and administrators; role of family, society and educational institutions in inculcating values.

UNIT II

- 1. Attitude: content, structure, function; its influence and relation with thought and behaviour; moral and political attitudes; social influence and persuasion; ethical leadership and servant leadership.
- 2. Aptitude and foundational values for Civil Service, integrity, impartiality and non partisanship, objectivity, dedication to public service, empathy, tolerance and compassion towards the weaker sections.
- 3. Emotional intelligence and Social intelligence- concepts, and their utilities and application in administration and governance.
- 4. Contributions of moral thinkers and philosophers from India and world.

UNIT III

- 1. Public/Civil service values and Ethics in Public administration: Status and problems; ethical concerns and dilemmas in government and private institutions; laws, rules, regulations and conscience as sources of ethical guidance; accountability and ethical governance; strengthening of ethical and moral values in governance; ethical issues in international relations and funding; corporate governance.
- 2. Probity in Governance: Concept of public service; Philosophical basis of governance and probity; Information sharing and transparency in government, Right to Information, Codes of Ethics, Codes of Conduct, Citizen's Charters, Work culture, Quality of service delivery, Utilization of public funds, challenges of corruption, Whistleblower Protection.

UNIT IV

1. Case Studies on the above issues including those relevant to Mizoram's context.
