NOTIFICATION

No.A. 12018/35/2016-P&AR (GSW), the 17th March, 2025: In exercise of the powers conferred by the proviso to Article 318 read with Article 309 of the Constitution, and in supersession of the Mizoram Public Service Commission (Group 'C' posts) recruitment Rules, 1994 notified in the Mizoram Gazette extraordinary issue **No. 34, dated 30.03.1994** and the Mizoram Public Service Commission (Group 'C' posts) recruitment Regulation, 2018 notified in the Mizoram Gazette extraordinary issue **No. 70, dated 15.02.2018**, except as respects things done or omitted to be done before such supersession, the Governor of Mizoram hereby makes the following rules regulating the method of recruitment to the posts of **Driver and Despatch Rider** under Mizoram Public Service Commission namely:-

| 1. Short title and commencement.- | (1) These rules may be called the Mizoram Public Service Commission (Group 'B' & 'C') Recruitment Rules, 2025.
(2) They shall come into force from the date of their publication in the Official Gazette. |
| 2. Application.- | These rules shall apply to the posts specified in Column - 1 of the Schedule - I annexed to these rules. |
| 3. Number of posts, classification and level in the pay matrix or pay scale.- | The number of the said posts, classification and level in the pay matrix or pay scale attached thereto shall be as specified in Column 2 to 4 of the said Schedule. |
| 4. Method of recruitment, age limit and other Qualifications.- | The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in Column 5 to 13 of the said Schedule. |
| 5. Disqualification.- | No person –
(a) who has entered into or contracted a marriage with a person having a spouse living; or
(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post(s); |

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other valid grounds for doing so, exempt any such person from the operation of these rule.

6. Training and Departmental Examination.-
Every officials recruited under these rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.
7. Power to relax.-
Where the Commission is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons in consultation with the Government in the Department of Personnel & Administrative Reforms.
8. Saving.-
Nothing in these rules shall affect any reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Ex-servicemen and other special categories of persons in accordance with the order issued by the Government of Mizoram from time to time in this regard.
9. Interpretation.-
If any question arises as to the interpretation of these rules, it shall be decided by the Commission in consultation with the Government in the Department of Personnel & Administrative Reforms.

Note: Where juniors who have completed their qualifying/eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/eligibility service.
