#### OFFICE MEMORANDUM

#### Subject: Reservations and other concessions in public appointments.

The State Government has been issuing instructions from time to time regarding the policy of reservation in appointments to posts and services under the State Government, and concessions/relaxations extended to Scheduled Castes (SCs), Scheduled Tribes (STs), Other Backward Classes (OBCs), Persons with Disabilities (PwDs), Ex-servicemen, etc.

2. With a view to facilitating easy accessibility and clear understanding of the instructions on reservation/concessions/relaxations, the relevant instructions on the subject have been consolidated, as under:

#### i) Reservation for Persons with Benchmark Disabilities:

As per this Department's **O.M. No. A-12027/1/2011-P&AR(GSW) Dated 18.02.2019,** four percent of the total number of vacancies in direct recruitment to each Group A, B, C, and D post shall be reserved for Persons with Benchmark Disabilities. The posts identified for reservation have been notified by the Government in accordance with sub-section (1) of section 33 of the Rights of Persons with Disabilities Act, 2016 (XX of 2016). #### ii) Reservation for Ex-servicemen:

According to the Mizoram Ex-servicemen (Re-employment in Civil Posts) Rules, 2019, notified vide No. A-12027/1/2016-P&AR(GSW) Dated 10.10.2019 and published in the Mizoram Gazette Extraordinary Issue No. 660 of 2019, five percent of the vacancies in direct recruitment to Group 'B' (Non-Gazetted), Group 'C' and Group 'D' posts in any recruitment year shall be reserved for ex-servicemen. The rules also provide for other concessions to ex-servicemen. ### iii) Recruitment and Promotion of Meritorious Sportspersons:

vide No. As per the comprehensive instructions issued A-12032/1/2019-P&AR(GSW) Dated 14.11.2019, five percent of the vacancies in direct recruitment to Group 'B', Group 'C' and Group 'D' posts, as per the recruitment rules, can be reserved for meritorious sportspersons, subject to the functional requirements of departments concerned. #### iv) Incentives for Home Guard Volunteers:

The Mizoram Home Guard Rules, 2010, issued vide **No. A.1201811I03-HM (HG) Dated 12th May, 2010** and published in the Mizoram Gazette Extraordinary Issue No. 158 of 2010, provided for the following incentives to Home Guard Volunteers for employment in Government services in various uniformed cadres (Group 'C' & 'D'):

1) Police: 10%

Excise and Narcotics: 5%Environment and Forest: 5%

4) Prisons: 5%

#### v) Age Relaxation:

This Department's Office Memorandum No. A-12011/1/2019-P&AR(GSW) dated 03.06.2019, published in the Mizoram Gazette Extraordinary Issue No. 375 of 2019, prescribed the upper age limits for direct recruitment applicable to various categories of candidates. These age limits shall be applied mutatis mutandis in Recruitment/Service Rules which contain the standard savings clause on reservations and other concessions:

3. It is also noted that the Recruitment/Service Rules contain a standard proviso regarding 'reservations and other concessions/savings', which reads as follows:

"Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Ex-servicemen and other special categories of persons in accordance with the order issued by the Government of Mizoram from time to time in this regard"

4. In view of the reservation and other concessions/savings clause incorporated in recruitment rules/service rules as mentioned above, it is clarified that any reservation or concession granted by the Government from time to time shall be deemed to have been incorporated in the relevant Recruitment/Service Rules containing the aforesaid proviso. No formal amendment to such rules shall be necessary for giving effect to the said provisions. Therefore, all administrative departments are instructed to take due cognizance of the instructions on reservation percentages as well as any other concessions for various categories of persons issued by the Government from time to time, and ensure their strict application in all relevant recruitment processes.
