## **NOTIFICATION**

No. A. 12018/81/2011-P&AR(GSW), the 31<sup>st</sup> May, 2013. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram after consultation with the Mizoram Public Service Commission is pleased to make the following Rules further to amend the Mizoram Home Department (Group 'A' post) Recruitment Rules, 2001 (hereinafter referred to as the Principal Rules) regulating the method of recruitment to the post of Assistant Director (Forensic Department) notified vide No. A. 12018/9/80-APT(B)/Vol/Pt dated 29.5.2001 published in the Mizoram Gazette Extraordinary Issue No. 112 dated 31.5.2001, namely:-

- 1. Amendment of Rule 1(1) of Principal Rules, short title and Commencement
- In the existing entries in Rule 1(1) of the Principal Rules-Short title and commencement, the following shall be substituted, namely:-
- "(1) These Rules may be called the Government of Mizoram Home (Forensic) Department (Group 'A' post) Recruitment (Amendment) Rules. 2013.
- (2) They shall come into force from the date of their publication in the Mizoram Gazette".
- 2. Amendment of Annexure-I

For the existing columns 1, 2, 7, 8, 11 and 12 of the Annexure-I of the Principal Rules, the following shall be substituted, namely:-

"Col. 1: Assistant Director (Serology)

Assistant Director (Toxicology)
Assistant Director (Chemistry)

Assistant Director (Questioned Document)
Assistant Director (Ballistics & Tool marks)

Assistant Director (Finger Print) and other post as

sanctioned from time to time.

Col. 2: 1 (one) post each of Col. 1 and as sanctioned from time

to time

Col. 4: PB-3 ^ 15600-39100/- with Grade pay of ^ 5400/-

Ex-282/2013 - 2 -

- Col. 7: Between 18 and 35 years relaxable by 5 years in the case of Scheduled Castes/Scheduled Tribes candidates.
- Col.8:1(a) Assistant Director (Serology): M. Sc with 55% marks in Forensic Science (Specialized in Serology and Biology) or M.Sc with 55% marks in Botany/Zoology/Bio-Technology/Bio-Chemistry/Micro-Biology/Molecular Biology.
  - (b) <u>Assistant Director (Toxicology)</u>: M. Sc with 55% marks in Forensic Science (Specialized in Toxicology and Chemistry) or M. Sc with 55% marks in Chemistry/ Toxicology/Pharmacology/Bio-Chemistry.
  - (c) <u>Assistant Director (Chemistry)</u>: M. Sc with 55% marks in Forensic Science (Specialized in Toxicology and Chemistry) or M. Sc with 55% marks in Chemistry/ Bio-Chemistry.
  - (d) <u>Assistant Director (Question Document)</u>: M. Sc with 55% marks in Forensic Science (Specialized in Questioned Document) or M. Sc with 55% marks in Chemistry/Physics/Botany/Zoology.
  - (e) <u>Assistant Director (Ballistics and Tool marks)</u>:
     M. Sc with 55% marks in Forensic Science (Specialized in Ballistics and Toolmarks) or M. Sc with 55% marks in Physics.
  - (f) <u>Assistant Director (Finger Print)</u>: M. Sc (in any subjects) with 55% marks & Expert certificate holder of AIBE (NCRB).
  - 2. Working knowledge of Mizo language at least Middle School standard.
  - 3. Desirable: Working experience in Forensic Science Laboratory.
- Col. 11: 60% of the sanctioned posts by direct recruitment and 40% by promotion.
- Col. 12: Promotion from Junior Scientific Officer of Mizoram Forensic Science Laboratory with not less than 5 years regular service in the grade".
