## **NOTIFICATION**

**No.A.12018/66/2009-P&AR(GSW), the 10<sup>th</sup> January, 2014.** In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules regulating the method of recruitment to the post of Deputy Director, Sainik Welfare & Resettlement Department further to amend the Mizoram Home Department (Sainik Welfare & Resettlement) (Group 'A' post) Recruitment Rules, 2002 (hereinafter referred to as the Principal Rules) notified vide No.A.12018/15/80-APT(B) dt.10.12.2002 and published in the Mizoram Gazette Extraordinary Issue No. 382 dt.19.12.2002, namely:-

1. Short title and commencement

- (1) These Rules may be called the Mizoram Home (Sainik Welfare & Resettlement) Department (Group 'A' post) Recruitment (Amendment) Rules, 2013.
- (2) They shall come into force from the date of their publication in the Mizoram Gazette.

2. Amendment of Annexure - 1

Entries under Column 1, 4 and 8 in the Annexure-1 of the Principal Rules, shall be substituted as follows, namely:-

"Column 1 : District Sainik Welfare and Resettlement Officer.

Column 4 : PB-3 ` 15600-39100 + Grade Pay of ` 5400

Column 8:

(a) Ex-Commissioned Officer/ExShort Service Commissioned Officer not below the rank of Captain in the Indian Army or its equivalent rank in Navy or Airforce. Or Serving Commissioned Officer not below the rank of Captain in the Army or its equivalent rank in Navy or Airforce.

- (b) In case of non-availability of Ex-Commissioned/Short Service Commissioned Officer, Ex-Junior Commissioned Officer not below the rank of Hony Captain in the Indian Army or its equivalent rank in Navy or Air Force will be considered.
- (c) Graduate or its equivalent. In case of non-availability of Graduate Ex-Commissioned/Ex-Short Service Commissioned Officer, Matriculate Ex-Junior Commissioned Officer will be considered.
- (d) Working knowledge of Mizo language of at least middle school standard.
