In the interest of public service, the Governor of Mizoram is pleased to place the services of **Pu Lalhriatpuia, Selection Grade of the Mizoram Civil Service** at the disposal of Mizoram Public Service Commission for appointment to the post of Controller of Examination, MPSC on deputation basis initially for a period of 3 (three) years with effect from the date of joining the post subject to the following terms & conditions:

1. The Officer shall make an option to draw either the Pay Band and Grade Pay of the deputation post or his own Pay Band and Grade Pay in the parent cadre without Deputation (Duty) Allowance.
2. The Officer so deputed to an ex-cadre higher Pay Band and Grade Pay shall have no right to claim the Pay Band and Grade Pay of the deputation post when he is repatriated to his parent cadre.
