No.A.12031/8(1)/2017-PAR(GSW) Aizawl, the 4th July, 2019: In the interest of public service and as per the decision of the Council of Ministers in its meeting held on 22.04.2019 conveyed vide No.J.11011/1/2019-POL/Vol-I dated 23.04.2019 and in exercise of the powers conferred by rule 8 of the Mizoram School Education Department (Group 'B' posts) Recruitment Rules, 2015, the Governor of Mizoram, in consultation with the Mizoram Public Service Commission vide No.A-5/LL/2017-MPSC dated 27th June, 2019, is pleased to allow one time relaxation of the provisions of the aforementioned recruitment rules for the purpose of filling up of 882 (eight hundred and eighty two) posts of Primary School Teacher and 64 (sixty four) posts of Middle School Teacher under School Education Department by direct recruitment on Muster Roll basis:

The qualification of pass in Mizoram Teachers Eligibility Test Paper-I (MTET-I) appearing at Serial No. 2 in Column-8 of Annexure-I of the Mizoram School Education Department (Group 'B' posts) Recruitment Rules, 2015 pertaining to the post of Primary School Teacher subject to the condition that the requisite qualification shall be obtained by the selected candidates within the first 5 (five) years of service failing which the appointment shall stand terminated without further notice.
- 2. The qualification of pass in Mizoram Teachers Eligibility Test Paper-II (MTET-II) appearing at Serial No. 2 in Column-8 of Annexure-I of the Mizoram School Education Department (Group 'B' posts) Recruitment Rules, 2015 pertaining to the post of Middle School Teacher subject to the condition that the requisite qualification shall be obtained by the selected candidates within the first 5 (five) years of service failing which the appointment shall stand terminated without further notice.
- 3. The requirement of Computer proficiency for direct recruitment to Group 'A', 'B' & 'C' posts as per the Mizoram Group 'A', 'B' and 'C' posts Service/Recruitment (Amendment) Rules, 2016 as amended.

- 5. The requirement of conducting written examination as per para 13 of the Mizoram Direct Recruitment (Conduct of Examination) Guidelines, 2018
