NOTIFICATION

No. A. 12018/1/90-P&AR(GSW), the 17th August, 1994. In exercise of the powers conferred by the proviso to Article 318 of the Constitution of India, the Governor of Mizoram is pleased to make the following Regulation relating to the recruitment to the post(s) of Secretary, Deputy Secretary, Under Secretary, Finance & Accounts Officer, Superintendent and Stenographer-I under the Mizoram Public Service Commission, namely :-

1. Short title and commencement. (i) These Regulations may be called the Mizoram Public Service Commission (Group 'A' posts) Recruitment Regulations, 1994.
(ii) They shall come into force from the date of their publication in the Official Gazette.
2. Application. The Regulations shall apply to the post(s) specified in Col. 1 of the Annexure-I hereto annexured.
3. Numbers of post, classification and scale of pay. The number of the said posts, their classification ~~and the~~ ~~cation~~ and scale of pay attached thereto shall be as specified in columns 2&4 to the Annexure-I aforesaid.
4. Method of rectt. age limit and other qualification. (4) The age limit qualifications and other matters relating to the said posts shall be as specified in column 5 to 14 of the said Annexure-I.

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories or persons by 5 years or as per order issued by the Govt. of Mizoram from time to time.

5. Disqualification. No person -
- (a) who has entered into or contracted a marriage with a person having a spouse living;
 - (b) who, having a spouse living has entered into or contracted marriage with any person shall be eligible for appointment to the said post.

Provided that the Commission may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for doing so exempt any person from the operation of these Regulations.

6. Training and Departmental Examination. Every Officer shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

7. Power to relax. Where the Commission is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing relax any of the provisions of these Regulations with respect to any class or category of persons.

8. Reservation, other concessions. Nothing in these Regulations shall effect reservation or other concessions required to be provided for the Scheduled Caste, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Government or of Mizoram from time to time in this regard.

9. Repeal & Saving. All previous Recruitment Rules made on the subject shall stand repealed on and from the date of commencement of these Regulations.

Provided that any action or actions taken under the Rules as repealed hereby shall be deemed to have been taken under these Regulations.
