#### **NOTIFICATION**

**No. A.12018/78/2011-P&AR(GSW), the 23<sup>rd</sup> July, 2012.** In exercise of the powers conferred by the proviso to Article 309 read with Article 243 K(3) of the Constitution of India and sub section (2) of section 349 of the Mizoram Municipalities Act, 2007, the Governor of Mizoram is pleased to make the following rules regulating to the recruitment to the post(s) of Assistant, Stenographer Grade-II, UDC and Stenographer Grade-III under State Election Commission, Mizoram, Namely:-

- 1. Short Title and Commencement
- (1) These Rules may be called the Mizoram State Election Commission (Group 'B' posts) Recruitment Rules, 2012.
- (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. Application

These rules shall apply to the posts specified in Column 1 of the Schedule annexed to these rules.

3. Number of posts, classification, pay band and grade pay/pay scale The number of the said post(s), their classification, Pay Band and Grade pay/pay scale attached thereto shall be as specified in columns 2 to 4 of the said Schedule.

4. Method of recruitment, age limit, qualifications, etc

The method of recruitment, age limit, qualification and other matters relating to the said post(s) thereto shall be as specified in columns 5 to 14 of the aforesaid Schedule.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Tribes/the Scheduled Castes and other special categories of persons in accordance with the orders issued by the Central Government or the Government of Mizoram from time to time.

5. Disqualification

No person-

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post(s);

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any such person from the operation of this rule.

6. Training and Departmental Examination

- Every Government servant recruited under these rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.
- 7. Powers to transfer

Notwithstanding anything contained in these rules, the Governor of Mizoram, in public interest, shall have the right and power to transfer any officer or official, so recruited under these rules to any post or position which is equivalent in rank or grade.

8. Power to relax

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing and in consultation with the Mizoram Public Service Commission through the Department of Personnel and Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

9. Reservation and other concessions

Nothing in these rules shall affect any reservation and relaxation of age limit and other concessions required to be provided for the Scheduled Tribe/the Scheduled Castes and other categories of persons in accordance with the orders issued by the Central Government or the Government of Mizoram from time to time in this regard.
