#### NOTIFICATION

**No. A. 12018/40/2021-P&AR(GSW), the 4<sup>th</sup> October, 2021.** In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Mizoram Police Radio Organization (Group 'B' posts) Recruitment Rules, 1987 and notified in the Mizoram Gazette extraordinary issue number 40(B) dated 29.04.1987 and the Mizoram Police Radio Organisation (Group 'B' ) Recruitment Rules, 1997 notified in the Mizoram Gazette extraordinary issue number 5 dated 29.01.1997, except as respect things done or omitted to be done before such supersession, the Governor of Mizoram hereby makes the following rules regulating the method of recruitment to the post(s) of **Inspector of Police(Operator), Inspector of Police(Cipher), Inspector of Police(Radio Mechanic) and Inspector of Police(Fitter)** under Home(Mizoram Police Radio Organization) Department, Government of Mizoram, namely :-

1. **Short title and commencement.-**
  - (1) These rules may be called the Mizoram Home (Mizoram Police Radio Organization) Department (Group 'B' posts) Recruitment Rules, 2021
  - (2) They shall come into force from the date of their publication in the Official Gazette.
2. **Application.-** These rules shall apply to the post(s) specified in Column I of the Schedule annexed to these rules.
3. **Number of posts, classification and level in the pay matrix or pay scale.-** The number of the said posts, classification and level in the pay matrix or pay scale attached thereto shall be as specified in Column 2 to 4 of the said Schedule.
4. **Method of recruitment, age limit and other qualifications.-** The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in Columns 5 to 13 of said Schedule.
5. **Disqualification.-** No person -
  - (a) Who has entered into or contracted a marriage with a person having a spouse living; or

(b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post;

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other valid grounds for doing so, exempt any such person from the operation of this rule.

6. **Training and Departmental Examination.-**

Every officials recruited under these rules shall undergo such training or pass such Departmental examination as may be prescribed from time to time.

7. **Power to transfer.-**

Notwithstanding anything contained in these rules, the State Government, in public interest, shall have the right and power to transfer any officials, so recruited under these rules to any other post or position which is equivalent in rank or grade.

8. **Power to relax.-**

Where the State Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, in consultation with the Mizoram Public Service Commission through the Department of Personnel and Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

9. **Saving.-**

Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Ex-Servicemen and other special categories of persons in accordance with the order issued by the Government of Mizoram from time to time in this regard.
