#### NOTIFICATION

**No.A.12018/17/2011-P&AR(GSW), the 5<sup>th</sup>.July, 2011.** In exercise of the powers conferred by the proviso to article 309 of the Constitution, the Governor of Mizoram is pleased to make the following rules regulating and method of recruitment to the post(s) of **Revenue Inspector** under Land Revenue and Settlement Department, Government of Mizoram namely :-

- 1. Short title and commencement-**
  - (1) These rules may be called the Mizoram Land Revenue and Settlement Department (Group'B' post) Recruitment Rules, 2011.
  - (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. Application-**

These rules shall apply to the posts specified in column 1 of the Schedule annexed to these rules.
- 3. Number of posts, classification, pay band and grade Pay/pay scale-**

The number of the said post(s), their classification pay Band and grade pay/ pay scale attached thereto shall be as specified in columns 2 to 4 of the said Schedule.
- 4. Method of recruitment, age limit, qualifications, etc-**

The age limit, qualification and other matters relating to the said post shall be as specified in Column 5 to 14 of the aforesaid Schedule.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/ the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the central Government or the Government of Mizoram, as the case may be from time to time.
- 5. Disqualification-**

No person-

  - (a) Who has entered into or contracted a marriage with a person having a spouse living; or
  - (b) Who, having a spouse living, has entered into or contracted a marriage with any other person, shall be eligible for appointment to the said post(s);

**6. Training and  
Departmental  
Examination-**

Every Government servant recruited under these rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

**7. Powers to transfer  
and posting-**

Notwithstanding anything contained in these Rules, the Governor of Mizoram, in public interest, shall have the right and power to transfer any officer so recruited under these rules to any other post or position in which is equivalent in rank or grade.

**8. Power to relax-**

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, in consultation with the Mizoram Public Service Commission through the Department of Personnel & Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

**9. Reservation and  
other concessions**

Nothing in these rules shall affect any reservation and other concessions required to be provided for the Schedules Caste/the Scheduled Tribes and other category of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time in this regard.
