NOTIFICATION

No.A.12018/26/2003-P&AR(GSW)/B, the 3rd August, 2015. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following Regulations to amend the Mizoram Subordinate Stenographers Service (Limited Departmental Examination) Regulations, 2004 (hereinafter referred to as the Principal Regulations) notified vide No. A. 12018/26/2003-P&AR (GSW) dated 16.01.2004 and published in the Mizoram Gazette Extraordinary Issue No. 24 dated 22.01.2004, namely:-

1. Short title and (1) commencement

(1) These Regulations may be called the Mizoram Subordinate Stenographers Service (Limited Departmental Examination) (Amendment) Regulations, 2015

- (2) These Regulations shall come into force from the date of publication in the Official Gazette
- 2. Amendment of Regulation 2
- (1) Sub-regulation (2) of Regulation 2 of the Principal Regulations shall be substituted as follows, namely;
 - "The date and venue of the examination shall be fixed by the Mizoram Public Service Commission"
- 3 Amendment of Regulation 5
- (1) Regulation 5 of the Principal Regulations shall be substituted as follows, namely:
 - "The decision of the Mizoram Public Service Commission as to the eligibility or otherwise of candidates for admission to the examination shall be final and no candidate to whom a certificate of admission has not been issued by the Mizoram Public Service Commission shall be admitted to the examination"
- 4. Amendment of Regulation 9
- (1) Regulation 9 of the Principal Regulations shall be substituted as follows, namely;
 - "The Limited Departmental Examination for the post of Grade-II as well as direct recruitment for the post of Grade-III shall be conducted with the syllabus as set forth in Appendices below"
- (2) Appendix-II of Regulation 9 of the Principal Regulations shall be deleted and the previous Appendix-III renumbered as Appendix-II"

APPENDIX - I

SYLLABUS FOR LIMITED DEPARTMENTAL EXAMINATION FOR THE POST OF PERSONAL ASSISTANT

English Stenography: (i) 100 Words per minute for 3 minutes dictation given by an expert in

English Stenography,

- (ii) 10 minutes for reconciliation,
- (iii) 30 minutes for typing,
- (iv) Maximum permissible errors: 10%

SYLLABUS FOR DIRECT RECRUITMENT EXAMINATION FOR THE POST OF STENOGRAPHER GRADE-III

(A) WRITTEN EXAMINATION (to be conducted for the purpose of selecting candidates to be eligible for Speed Test in English Stenography only):

SI. No	Subject	Full Marks	Pass Marks	Time
1.	Gen. English	100	40	3 Hrs
2.	Gen. Knowledge	100	40	3 Hrs

- (B) Candidates who qualify themselves in the Written Examination shall be called for Speed Test in English Stenography.
- (C) English Stenography: (i) 80 Words per minute for 5 minutes dictation given by an expert in English Stenography,
 - (ii) 10 minutes for reconciliation,
 - (iii) 30 minutes for typing,
 - (iv) Maximum permissible errors: 10%
- (D) Candidates who qualify themselves in English Stenography shall be called for Personal Interview.
- (E) PERSONAL INTERVIEW: 50 Marks
