NOTIFICATION

The Mizoram Public Service Commission (Limitation of Functions) Regulations, 1994 as amended specified matters in which it shall not be necessary for the Mizoram Public Service Commission to be consulted in matters of recruitment to services and posts in connection with the affairs of the State of Mizoram.

The Mizoram Public Service Commission (Limitation of Functions) (Amendment) Regulations, 2019, notified vide No.A.12017/2/2003-P&AR(GSW) dt. 17.06.2019 and published in the Mizoram Gazette extra ordinary issue No. 399 dt. 21.06.2019, came into force on 21.06.2019 i.e. the date of publication in the Official Gazette.

Regulation 3(a) of the said amendment regulations stipulated that it shall not be necessary for the Commission to be consulted in matters relating to methods of recruitment to civil services and post or on the suitability of the candidates for such appointments in case of appointment through direct recruitment by the Governor or by an authority other than the Governor in respect of Group 'B' (Non-Gazetted), Group 'C' and Group 'D' posts.

Further, regulation 4(d) of the said amendment regulations stipulated that it shall not be necessary for the Commission to be consulted on the principles to be followed in making promotions or the suitability of candidates for promotion in case of promotion through limited departmental examination from a lower to a higher post/grade to Group 'B' (Non-Gazetted) posts and below.

The Commission subsequently returned all pending requisitions for filling up of posts through the methods of direct recruitment and limited departmental examination pertaining to all Group 'B' (Non-Gazetted) posts to the Government vide No-A12032/1/2019-MPSC(DR) dt. 22.07.2019.

However, the Departmental Promotion Committee for recruitment through various methods to Group 'B' (Non-Gazetted) posts viz. the Mizoram Subordinate Services Selection Board, though notified vide No.A-12026/1/2019-P&AR(GSW) dt. 19.05.2019 and published in the Mizoram Gazette Extra ordinary issue No. 418 dt. 25.06.2019, has not yet become functional till date pending appointment of Chairman and Member and recruitment/posting of Officers and staff for the newly constituted Board.

In view of the above stated positions, the Governor of Mizoram is pleased to order that requisitions for recruitment by the method of direct recruitment or limited departmental examination or any other method of recruitment for which the Commission has already initiated the process of recruitment by issuing an advertisement as on 21.06.2019 i.e. the date of publication of the Mizoram Public Service Commission (Limitation of Functions) (Amendment) Regulations, 2019 in the Official Gazette, shall henceforth be completed by the Commission and those requisitions for recruitment by the method of direct recruitment or limited departmental examination or any other method of recruitment for which the Commission has not yet initiated the process of recruitment by issuing an advertisement as on 21.06.2019 shall be taken up by the Mizoram Subordinate Services Selection Board (MSSSB) as and when the Board becomes functional.


