

**MINUTES OF MEETING OF SCREENING COMMITTEE FOR NATIONAL AWARD  
FOR E-GOVERNANCE HELD AT THE OFFICE CHAMBER OF ADDL. CHIEF  
SECRETARY, DP&AR DATED 27.08.2013 (11.00AM)**

Welcoming the members, the Chairman apprised them the purpose of the meeting. Department of Administrative Reforms & Public Grievances (DARPG), Govt. of India has invited nominations for the National Award for e-Governance 2013-14 for recognizing and promoting excellence in e-Governance initiatives under the Central/State Governments/PSUs in 12 different categories.

DP&AR (Good Governance Cell), being the nodal Department, accordingly invited nominations from all Departments under the Government of Mizoram. In response to the invitation, Taxation Department had submitted a project entitled "Commercial Taxes-Mission Mode Project" under the category of "Excellence in Government Process Re-engineering" through the Department of Information & Communication Technology (ICT).

However, the Committee was informed by Secretary, ICT that the same nomination had been scrutinized by a separate Committee under the Chairmanship of the Chief Secretary and submitted to DARPG, Govt. of India vide No.A.37020/1/2008-PLG(ICT) dated 30.07.2013 as a nominee for the National Award for e-Governance 2013-14. Considering the fact that the same nomination had been sent by ICT Department earlier for the same Award, the Screening Committee decided that the nomination submitted earlier by ICT Department may be accepted for the current year and separate nominations may not be sent to DARPG, Govt. of India.

The Committee further decided that DP&AR (Good Governance Cell), being the nodal Department in matters relating to National Award for e-Governance, nominations in subsequent years may be screened and submitted through the Screening Committee formed by the Government in DP&AR (Good Governance Cell) only.
