OFFICE MEMORANDUM

Dated Aizawl, the 31st Aug, 2009

All Administrative Departments and Heads of Departments are requested to refer to this Departments Office Memorandum of even No. dated 03.09.1992 regarding proposals for direct recruitment into Government services for the posts carrying the maximum pay scale of Rs. 2900/- (4th Pay Commission) and above to be referred to the Mizoram Public Service Commission. All Departments are hereby informed that all cases of direct recruitment for Group 'A' and 'B' posts shall be referred to the Mizoram Public Service Commission as per Notification of even no. dt.29.8.2008 and even no dt.19.3.2009. For exceptional and extreme emergency cases requiring invocation of the provisions 3(e) or 3(f) of Mizoram Public Service Commission (Limitation of Functions) Regulations, 1994, suitable proposal may be submitted to the Department of P&AR for examination.

All Departments are also requested to refer to the Department's Office Memorandum No.A.32012/1/81-APT(B) dt 15.4.1996. It is hereby reiterated that cases of promotion to Group 'A' and 'B' (Gazetted and Non-Gazetted) posts under the Government of Mizoram shall continue to be submitted to the Mizoram Public Service Commission through the Department of Personnel & Administrative Reforms.

Attention is also invited to Office Memorandum No. G. 11011/1/99 - F.Est.Dt.14.6.2009 regarding concurrence of Finance Department for case of promotion of Government Officials. All Departments are hereby informed that concurrence of the Finance Department is necessary in all cases of promotion except in case of officers in the Scale of Rs 10,000/- and above, provided that such posts are to be filled up cent percent by promotion only.

The Department of P&AR have also received from some Departments, proposals for officiating promotions invoking the provision of Regulation 4(c) of the Mizoram Public Service Commission (Limitation of Functions) Regulations, 1994. All Departments are hereby informed that this provision is made by the Government for officiating promotions to temporary vacancies for a period which is not likely to last for more than 1(one) year only. The officiating promotion by invoking Regulation 4 (c) of the MPSC (limitation of functions) Regulations 1994 should not be resorted to save in the case of extreme necessity in public interests and that too, with prior approval of DP&AR and concurrence of Finance Department. Even on such occasion, resultant vacancy should not be filled up.
