OFFICE MEMORANDUM

Subject :- Relaxation of age for appointment to Government Servant by direct recruitment.

The undersigned is directed to refer to this Department. letter of even number dated 15.1.1085 and to state that relaxation of the upper age limit for appointment to Group 'A' & 'B' posts is allowed for Government Servants upto 5 years for direct recruitment vide Government of India, DP & AR 0.N.NO.CSL-14017/1/82-Estt(RR) dt.3.9.82 and No. CSL-14017/1/82-Estt(RR) dt.4.6.83. Similarly, as per Govt. of India, DP & AR 0.N.NO.4/4/74-Estt(D) dt.20.7.76 relaxation of the upper age limit for departmental candidates for appointment to Group 'C' & 'D' posts'. were allowed upto 5 years. The age concession will be admissible only where an employee has rendered not less than three years continuous service in the same Department.

- Again as per Govt. of India, DP & AR O.M.NO.4/4/74-Estt(b) dt.9.4.81 decissions have been taken by the Govt. that Govt. Servant may not be allowed any relaxation of age for recruitment to Group 'A' & 'B' posts on the basis of competitive examinations held by the Commission, except in cases where it has been specifically provided for in the scheme of examinations approved in consultation with the Commission. However, in the O.M. referred to above it is stated that Government Servant may be allowed, on uniform basis, relaxation of maximum of 5 years in the upper age limit for recruitment to other Group 'A' & 'B' posts by advertisements through the Commission provided that the age relaxation will be admissible to such of the Government Servant as are working in posts which are in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duties of the post(s) recruitment to which has been advertised.
- At the same time, the Govt. of India, Ministry of Home Affairs vide their Resolution No.42/19/51-NGS dt.25.6.52 and Resolution No.15/1/42/19/52-NGS dt.30.4.55 have allowed the maximum age limit presented for appointment to a non-Casetted and Casetted posts to be increased by 5 years.

- 4., The Government of India, Ministry of Personnel, Public Grievances and Pensions, Deptt. of Personnel & Training vide their No. 656/92-Estt(D) dt.27.3.1992 have clarified that the ago relaxation allowed Government Servant for direct recruitment in incladed tion to the ago relaxation admissible to him ago condition belonging to Scheduled/Scheduled Tribe.
- In order to avoid complications in future, all Administrative Departments and all Heads of Departments are requested to bring this O.il. to the notice of all concerned officers in their respective Departments.
