Similarly, in order to promote healthy competition and to create conducive environment among State Government's Departments, a Core Group to study/examine the policy for assessment of performance developed under PMES known as 'Results Framework Documents' (RFD) is hereby constituted comprising of the following members:

Terms of reference of the Core Group will be as follows:


1. The Core Group shall examine the feasibility and possibility of adopting the system presently used by the Central Government for the State Government. They shall also develop the system using which the performance of all Departments under the State Government can be monitored, evaluated and promoted.
2. The Core Group shall also examine the possibility of inter-linking the performance of each department assessed under this system with their annual plan budgetary allocation in order to make the system of assessment effective.
3. The Core Group is expected to submit their final report within six months from the date of issue of this Notification.
