- 7. List of eligible candidates as provided in para 3 of the 'Government of Mizoram Regularization of Centrally Sponsored Scheme (CSS) Employees Scheme, 2024'.
- 8. Report/recommendation of Performance Evaluation Committee. The Committee shall verify the eligibility of the CSS Employees and recommend eligible candidates for further consideration of the concerned DPC.
- 9. Inter-se-seniority of eligible CSS employees under the Department.
- **10.** Documents supporting educational & other qualifications prescribed by the relevant Recruitment Rules.
- 11. List of Provisional Employees and Contract Employees, if any, against the post(s) proposed to be filled.
- 12. Roster (Post-based and Vacancy-based) of the post(s) proposed to be filled.
