Attention of all Administrative Departments/Heads of Departments is invited to the decision taken by the Council of Ministers in its meeting held on 18 & 19th May, 2011 and subsequent Notification issued by Finance Department vide No.G.12020/1/2010-FIN (PRU) dated 26.5.2011. Accordingly, the rates of monthly remuneration of Contract Employees under the State Government are hereby enhanced/revised as follows with retrospective effect from 1.1.2011 :
