## GOVERNMENT OF MIZORAM DEPARTMENT OF PERSONNEL & ADMINISTRATIVE REFORMS (GENERAL SERVICE WING)

### NOTIFICATION

**No.A-32012/1/2011-P&AR(GSW)** Aizawl, the 7<sup>th</sup> July, 2020: With the commencement of the Mizoram Recruitment/Service (Amendment) Rules, 2020 notified vide No.A-32012/1/2011-P&AR(GSW) dt. 16.06.2020 (*Annexure*) and published in the Mizoram Gazette extraordinary issue No 366 dt. 23.06.2020, the State Government hereby constituted the Departmental Promotion Committee in respect of the following posts (with the exception of posts under the judiciary) for which:

- a) consultation with Mizoram Public Service Commission is not required as per the Mizoram Public Service Commission (Limitation of Functions) Regulations, 1994 as amended; or
- b) consultation with Mizoram Subordinate Services Selection Board is not required as per the delegation of functions to the Board from time to time, namely;
  - Chairman : Secretary of the Department concerned Members : 1. Head of Department concerned 2. Representative of Department of Personnel and Administrative Reforms (DP&AR)

**Note 1:** In case there are more than one Secretaries in a Department, the senior most Secretary shall be the chairman of the Departmental Promotion Committee.

**Note 2:** In case there are more than one Heads of Department in a Department, the senior most officer holding the charge of Head of Department shall be the member of the Departmental Promotion Committee.

**Note 3:** The chairmanship of the Departmental Promotion Committee shall not normally be delegated by the Secretary to his subordinate official such as an Additional Secretary or a Joint Secretary unless there are compelling reasons which prevented the Secretary from discharging his duties as the chairman of the Departmental Promotion Committee. In case such eventuality arises, delegation of the chairmanship should be done in writing with reasons thereof before the meeting of the Departmental Promotion Committee is scheduled to be held.

**2.** Subsequent to the commencement of the aforesaid amendment rules, the State Government, notwithstanding anything in the first paragraph of this notification, further constituted the Departmental Promotion Committee, in respect of posts for which recruitments are to be done district wise, insofar as they relate to posts (with the exception of posts under the judiciary) for which consultation with the following bodies is not required:

- a) Mizoram Public Service Commission as per the Mizoram Public Service Commission (Limitation of Functions) Regulations, 1994 as amended; or
- b) Mizoram Subordinate Services Selection Board as per the delegation of functions to the Board from time to time, namely;
  - Chairman : Deputy Commissioner of the concerned district
  - Members : 1. Head of office conducting recruitment in the concerned district or senior most Additional Deputy Commissioner of the district in respect of recruitment in the establishment of the Deputy Commissioner.
    - 2. Representative of Department of Personnel and Administrative Reforms (DP&AR)

**Note:** In case more than one district wise direct recruitment are done concurrently in a recruitment year, a consolidated order of merit shall be drawn up by the department concerned on the basis of the aggregate marks obtained by the candidates, both in the written examination and personal interview.

**3.** Subsequent to the commencement of the aforesaid amendment rules, the State Government, notwithstanding anything in the first and second paragraph of this notification, also constituted the Departmental Promotion Committee, in respect of posts for which recruitments are to be done outside the State of Mizoram (viz. Mizoram Houses, etc.), insofar as they relate to posts (with the exception of posts under the judiciary) for which consultation with the following bodies is not required:

- a) Mizoram Public Service Commission as per the Mizoram Public Service Commission (Limitation of Functions) Regulations, 1994 as amended; or
- b) Mizoram Subordinate Services Selection Board as per the delegation of functions to the Board from time to time, namely;

Chairman	:	Secretary or Additional Secretary or Joint
		Secretary of the Department concerned
Members	:	1. Head of office concerned
		2. Representative of Department of Personnel and Administrative Reforms (DP&AR)

**4.** Notwithstanding anything in the first, second and third paragraph of this notification, the State Government hereby declared that the composition of the Departmental Promotion Committee or Selection Board insofar as they relate to posts in Mizoram Police under Home Department for which consultation with Mizoram Public Service Commission is not required as per the Mizoram Public Service Commission (Limitation of Functions) Regulations, 1994 as amended shall be as prescribed in the relevant provisions of the Mizoram Police Manual, 2005 as

amended. The Police Establishment Board constituted under section 39 of the Mizoram Police Act, 2011 shall not be consulted for various methods of recruitment as specified in paragraph 5 of this notification since it lies outside the functions of the Police Establishment Board as prescribed in section 39 of the Mizoram Police Act, 2011.

5. The Departmental Promotion Committees as constituted by the State Government shall be consulted for the following methods of recruitment/cases unless otherwise expressly provided in the recruitment rules/service rules in respect of posts specified in rule 2 of the aforesaid amendment rules, namely;

- a) Appointment by direct recruitment;
- b) Appointment by promotion;
- c) Appointment by limited departmental examination;
- d) Appointment by absorption;
- e) Appointment by regularisation;
- f) Confirmation of officials on probation.

## NOTIFICATION

No. A. 32012/1/2011-P&AR(GSW), the 16<sup>th</sup> June, 2020. In exercise of the powers conferred by the proviso to article 309 of the Constitution the Governor of Mizoram hereby make the following rules to amend the recruitment rules/service rules under the Government of Mizoram, namely;

- 1. Short title and commencement.-
- (1) These rules may be called the Mizoram Recruitment/Service (Amendment) Rules, 2020.
- (2) They shall come into force from the date of their publication in the Official Gazette.
- Application.- (1) These rules shall be applicable to all the recruitment rules/service rules under the Government of Mizoram insofar as they relate to posts for which consultation with the following bodies is not required:
  - a) Mizoram Public Service Commission as per the Mizoram Public Service Commission (Limitation of Functions) Regulations, 1994 as amended; or
  - b) Mizoram Subordinate Services Selection Board as per the delegation of functions to the Board from time to time
  - (2) These rules shall not be applicable to recruitment rules regulating the method of recruitment to posts under the judiciary
- 3. Amendment of recruitment rules.- In all recruitment rules as specified in rule 2 of these rules, in the Schedule Annexure pertaining to the composition of Departmental Promotion Committee, the following shall be substituted, namely;

"If Departmental Promotion Committee exists, what is its composition?

Departmental Promotion Committee as constituted by the Government from time to time"

4. Amendment of service rules.- In all service rules as specified in rule 2 of these rules, in the entries pertaining to the composition of Departmental Promotion Committee, the following shall be substituted, namely;

" Departmental Promotion Committee as constituted by the Government from time to time"
