OFFICE MEMORANDUM

Subject: Temporary suspension of mandatory induction/ foundation training.

The Government of Mizoram has issued an order for temporary suspension of mandatory induction/ foundation training vide A.31011/1/2019-P&AR (GSW) dt. 14.08.2020. The suspension of such training was to solve undue hardship faced by the government servants who have completed the prescribed probation period and fulfil all other conditions for confirmation as per the extant instruction but have no chance to undergo mandatory training.

2. The government has received a number of references in the above matter that the Administrative Training Institute is not in a position to impart regular training due to the Covid-19 pandemic. After due consideration of the issue, the Government hereby temporarily suspends the requirement of mandatory induction/ foundation training prescribed at para 2 (1) of this Department's O.M No.A.31011/1/2019-P&AR (GSW) dt. 14.06.2019 in respect all direct recruits, absorbees, contract or work-charged or provisional employees who have completed the prescribed period of probation as on 30.06.2021 or till the training programmes can be resumed whichever is later, so that such all government servants shall be considered for confirmation subject to fulfilment of all conditions prescribed in the said Office Memorandum.

3. It should also be noted that Government servants who are confirmed during the said period and have not attended mandatory/foundation training shall undergo training whenever called upon to do so by the authority.
