MINUTES OF MEETING ON THE MIZORAM RIGHT TO PUBLIC SERVICES ACT, 2015 HELD UNDER THE CHAIRMANSHIP OF SECRETARY, DP&AR AT SECRETARIAT CONFERENCE HALL ON 09.11.2015

Welcoming the members, the Chairman apprised them purpose of the meeting and outlined the basic tenets of the Mizoram Right to Public Services Act, 2015 which mandated time bound delivery of notified public services to citizens. The meeting was informed that the Mizoram Right to Public Services Act, 2015 (Act No. 6 of 2015) was unanimously passed by the seventh Legislative Assembly of Mizoram on the 24th March, 2015 and received the assent of the Governor on the 25th March, 2015. The corresponding Mizoram Right to Public Services Rules, 2015 have also been framed and duly notified in the Mizoram Gazette Extra-ordinary issue No. 434 on 27.08.2015.

The Act is considered a bold initiative of the Government for reforms in public service delivery with the overall objective of ensuring an accountable, responsive and transparent governance, in short Good Governance. The Act will perhaps be a counterpart of the RTI with regard to delivery of notified public services. The Mizoram Right to Public Services Act, 2015 and the corresponding Mizoram Right to Public Services Rules, 2015 will come into force on the 1st December, 2015.

The meeting discussed various modalities for implementation of the Act and resolved on the following points:

1. Finalisation of list of public services to be notified under Section 4 of the Act: Section 4(1) of the Act empowered the State Government to notify services, from time to time, to be public services for the purpose of the Act and to specify the time limit within which such services shall be provided to the eligible persons. The meeting meticulously reviewed the proposed list of public services Department-wise and the state of readiness of the Department for implementation of the various provisions of the Act with particular reference to the proposed list of public services under the Departments concerned.

The meeting, after detailed deliberation, decided that the list of services mentioned in *Annexure-II* may be proposed for notification as public services to be delivered within a stipulated time limit as per Section 4(1) of the Act with effect from 01.12.2015. It was further decided that the list of services mentioned in *Annexure-III* may be reviewed and considered by the Departments concerned, preferably within the next one month, for notification as public services under Section 4(1) of the Act at a later date.

2. Appointment of Nodal Officers under Mizoram Right to Public Services Act, 2015 in Departments: The meeting was informed that appointment of Nodal Officer in each Department is essential to serve as the focal point for handling various issues related to implementation of the Mizoram Right to Public Services Act, 2015 within the respective Department and to coordinate with DP&AR (Good Governance Cell) as well as the respective Designated Officers, First Appellate Authorities and Second Appellate Authorities in their Departments, especially with regard to monitoring and implementation of the provisions of the Act. Subsequently, Nodal Officers for the Act have been nominated by 13 Departments and other Departments are informed to expedite the process of nomination of Nodal Officer. Appointment of the Nodal Officers under the Act may be notified by DP&AR (GGC).

Action: DP&AR(GGC)

3. Training of Nodal Officers on Mizoram Right to Public Services Act, 2015: The meeting decided that DP&AR (GGC) may arrange training of the Nodal Officers on the various provisions of the Mizoram Right to Public Services Act, 2015 as well as the Mizoram Right to Public Services Rules, 2015 preferably within the next one week. The

Nodal Officers will subsequently serve as Master Trainer for their respective Department and impart training to the respective Designated Officers, First Appellate Authorities and Second Appellate Authorities in their Departments.

Action: DP&AR(GGC)

4. Training of Designated Officers, First Appellate Authorities and Second Appellate Authorities on Mizoram Right to Public Services Act, 2015: The meeting agreed that Departments may arrange training of the Designated Officers, First Appellate Authorities and Second Appellate Authorities for each of the notified services in their Departments through the Nodal Officer cum Master Trainer, preferably not later than 24.11.2015 (Tuesday).

Action: All Nodal Officers

5. Provision of Forms under Mizoram Right to Public Services Rules, 2015: The meeting was informed that several statutory Forms have to be maintained by the Designated Officers, First Appellate Authorities and Second Appellate Authorities under the Mizoram Right to Public Services Rules, 2015. The Forms as shown below shall be provided by the Department/Authorities concerned as follows:

The meeting agreed that the Notice Board to be displayed at the office premises of all the Designated Officers may be provided by the respective Departments so that there is uniformity within a Department. This may be completed not later than **30.11.2015** (**Monday**) such that all such Notice Boards are displayed by the 1st December, 2015.
